

Seehafer Broadcasting General Contest Rules

Applicability of General Rules

These General Contest Rules apply to all Seehafer Broadcasting contests and promotions unless otherwise stated in the Official Rules for a specific promotion. In the event of a conflict between the General Contest Rules and the Official Rules for a specific promotion, the Official Rules for that promotion will govern.

Prize

Non-cash prizes are not redeemable for cash. Winners may not request prize substitution. Prizes are non-transferable and may not be claimed or used by any person other than the winner. Winners must claim their prizes within 30 days after the end of the contest. Prizes not claimed within the 30-day period will be forfeited.

All contest winners must meet standard eligibility requirements outlined for each promotion, and prizes are subject to availability and verification. Unless otherwise specified within a specific contest's rules, there is no limit on how frequently a listener can win.

Eligibility

All entrants must be at least 18 years old (unless otherwise specified within a specific contest's rules) and legal residents of the United States. Employees of Seehafer Broadcasting (including their immediate families and members of the same household) or its affiliates, promotional sponsors, advertising and promotional agencies who do business with Seehafer Broadcasting, Inc. are not eligible to participate in any contest presented. The term "immediate family" includes spouses, siblings, parents and legal guardians, children and legal wards, grandparents, and grandchildren, including "in-laws".
